



Cadangan - Cadangan Undi Pos

BERDASARKAN PERATURAN PILIHAN RAYA

(PENGUNDIAN POS) 2003

Pendahuluan

Undi Pos merupakan salah satu tiga jenis undi di Malaysia (sewaktu pilihan raya) selain daripada undi awal dan undi biasa. Peningkatan bilangan pengundi yang layak menjadi pengundi pos selepas Pilihan Raya Umum (PRU14) telah menimbulkan persoalan mengenai pembaharuan proses undi pos. Ini adalah Laporan oleh kami, Tindak Malaysia, bagi mengusulkan pindaan pindaan ke atas peraturan pengundian pos yang termaktub dalam Peraturan-Peraturan Pilihan Raya (Pengundian Pos) 2003 (“Peraturan”) di bawah Akta Pilihan Raya 1958 (Akta 19). Tujuan laporan ini adalah untuk menekankan kepentingan dan kecemasan dalam pelaksanaan beberapa prosedur yang perlu dilakukan oleh Suruhanjaya Pilihan Raya Malaysia (SPR). Dilampirkan dalam Lampiran (dalam Bahasa Inggeris) adalah draf yang mengandungi pindaan tersebut dalam teliti. Walaupun tindakan-tindakan berikut adalah terbaik untuk dilaksanakan melalui pindaan Peraturan, ia boleh dilaksanakan dengan segera menggunakan Pemberitahuan dalam Warta Kerajaan P.U (B).

Pengundi Pos Luar Negara

**Untuk seksyen ini, kita lebih merujuk kepada pengundi pos luar negara yang bukan pemilih tidak hadir dan selain daripada pengundi yang layak untuk undi pos dalam Peraturan-Peraturan Pilihan Raya (Pengundian Pos) 2003*

Dalam Pemberitahuan Di Bawah Subperaturan 3(3) (P.U. (B) 481) dan Pemberitahuan Di Bawah Perenggan 3(1)(e) yang telah dinyatakan atas Warta Kerajaan Persekutuan pada 7.10.2022 (tiga hari sebelum pembubaran Parlimen), SPR telah menetapkan beberapa kategori pengundi dilayak untuk mendaftar sebagai Pengundi Pos berikut Subperaturan 3(3) dan Perenggan 3(1)(e). Termasuk dalam kategori-kategori tersebut adalah pengundi yang berwarga negara Malaysia yang bertinggal di luar negara. Ini termasuk pengundi Malaysia yang menetap di kawasan-kawasan berhampiran dengan Malaysia (contohnya, Singapura) di mana sebelum ini, pengundi kawasan tersebut harus mengundi secara biasa (bukan pos).

Walau bagaimanapun, masa Pemberitahuan tersebut telah mengurangkan masa untuk pengundi luar negara Malaysia untuk berdaftar sebagai pengundi pos. Kita mengakui penambahan baik SPR telah membuat untuk pendaftaran (iaitu mengikut pautan talian). Akan tetapi, kesuntukan masa untuk berdaftar (pengundi pos luar negara – 10/10 – 23/10/23) dan jangka masa pendek antara hari penamaan calon dan hari mengundi telah menyebabkan pengundi terlepas peluang untuk melaksanakan hak pengundi. Anggaran Pertubuhan Bangsa Bangsa Bersatu telah menunjukkan seramai 1.86 juta orang Malaysia menetap dan bekerja di luar negara. Untuk Pilihan Raya Umum Ke-15 (PRU15), anggaran 50 000 warganegara Malaysia yang menetap luar negara telah mendaftarkan sebagai pengundi pos.

Kepentingan Undi Pos Luar Negara adalah kemudahan Warganegara Malaysia yang menetap di luar negara untuk menggunakan hak-hak mereka untuk mengundi tanpa keperluan membaliik ke Malaysia yang boleh menyebabkan kesusahan. Justeru, ia adalah penting untuk warganegara-warganegara tersebut untuk diberitahu prosedur yang ditetapkan untuk memastikan undian tersebut boleh dijalankan tanpa halangan dan kejahanan.

Cadangan 1 (Tanpa melibatkan pindaan undang-undang)

SPR mampu memberi Pemberitahuan (mengenai pengelasan pengundi Luar Negara untuk Undi Pos) dalam Warta Kerajaan untuk menetapkan prosedur prosedur yang dinyatakan secara awal. Ini selaras dengan Perenggan 3(1)(e) “seorang anggota mana-mana kategori orang yang ditetapkan sebagai pengundi pos oleh Suruhanjaya Pilihan Raya dari semasa ke semasa melalui pemberitahuan dalam Warta,” SPR boleh mewartakan pengundi Luar Negara dan memulakan proses pendaftaran Luar Negara tiga hingga enam bulan sebelum pembubaran Parlimen atau DUN. Adalah tanggungjawab pengundi luar negara, bukan SPR, untuk memaklumkan bahawa pengundi tersebut telah kembali ke Malaysia and memohon untuk menjadi pengundi biasa.

Cadangan 2 (Tanpa melibatkan pindaan undang-undang)

Untuk membenarkan pengundi luar negara (pengundi pos), jurang masa antara hari penamaan calon dan hari mengundi perlu dipanjangkan sekurang-kurangnya 28 hari. Walaupun sesetengah pengundi Malaysia menetap di negara-negara maju, isu sistem pos luar negara, jarak jauh dari Malaysia dan halangan lain menyebabkan undi pos mungkin sampai kepada tangan pengundi amat lawat. Bergabung dengan Cadangan 1, pengundi Malaysia luar negara boleh mendapat hak untuk mengundi.

Cadangan 3 (Melibatkan pindaan undang - undang)

Kami bercadang pindaan tersebut atas Peraturan untuk mengekalkan kategori kategori yang dijelaskan dalam Pemberitahuan tersebut, dan menetapkan prosedur yang jelas dan adil. Pindaan tersebut akan dipinda sebagai Peraturan 3A. Draf untuk legislasi tersebut dinyatakan dalam Lampiran di bawah.

- a. Sesiapa yang mendaftar sebagai Pengundi Tidak Hadir (PTH) di bawah Peraturan-Peraturan Pilihan Raya (Pendaftaran Pemilih) 2002, dan sebelum pembubaran Parlimen atau DUN, telah menghantar Borang yang berkenaan untuk menerima kertas undi melalui pos akan berhak untuk undi sebagai pengundi pos luar negara apabila beliau menerima kertas undi tersebut.
- b. Pengundi tersebut boleh mendaftar (menggunakan Borang 1A) melalui Pegawai Konsular Malaysia di negara yang pengundi tersebut menetap. Pegawai Konsular Malaysia mesti menghantar Borang tersebut kepada SPR.
- c. SPR diwajibkan untuk mengekalkan daftar pengundi pos luar negara, yang dibuka untuk inspeksi umum atas talian.

- d. Pengundi tersebut akan mengekal sebagai pengundi pos luar negara sehingga pilihan raya umum parlimen tersebut bertamat, atau memohon untuk dipindah sebagai pengundi.

Oleh demikian, provisi untuk berian dan terimaan kertas-kertas undi juga perlu dibayangkan. Kepentingan ini adalah untuk provisi yang dipinda adalah konsisten seluruh Peraturan tersebut. Draf dalam lampiran akan menjelaskan prosedur-prosedur yang terperinci berkaitan dengan masa, tempat, dan cara-cara untuk melaksanakan proses undian; termasuk peranan pegawai konsular, prosedur prosedur keselamatan, gunaan karung yang dikunci dan sebagainya. Bahkan, kalau Peraturan 3A akan ditambahkan, ia akan dibayangkan dalam peraturan-peraturan tersebut

- a. Dalam Peraturan 7, tandaan kertas undi juga perlu ditandakan atas kertas undi pos luar negara.
- b. Dalam Peraturan 13A, prosedur tersebut juga perlu menyesuaikan untuk undi pos luar negara.

Cadangan 4 (Tanpa melibatkan pindaan undang-undang)

Sebagai wakil-wakil negara Malaysia di luar negara, kedutaan atau Pejabat Diplomatik harus membantu proses undian tersebut untuk kemudahan pengundi luar negara (dengan kerjasama SPR). Ini termasuk (tetapi tidak terhad kepada):

- a. Kedutaan atau Pejabat Diplomatik untuk bermain peranan untuk menerima dan menyampaikan kertas-kertas undi kepada pengundi.
- b. Kedutaan/Pejabat Diplomatik selepas undian untuk memberi kertas-kertas undi kepada Pegawai Pengurus. Kedutaan/Pejabat Diplomatik boleh menggunakan beg diplomatik (“diplomatic pouches”) dan bekerjasama dengan SPR untuk memastikan undi-undi disampaikan kepada Pegawai Pengurus.
- c. Kedutaan/Pejabat Diplomatik perlu tunjukkan sokongan atau memberi ruang kepada organisasi bertauliahan untuk Pengundi-pengundi luar negara boleh diberikan pilihan sama ada menghantar undi pos ke Pejabat Pegawai Pengurus atau menggunakan perkhidmatan Pejabat Diplomatik Malaysia di negara mereka menetap. Ejen calon atau ejen parti politik patut diberi ruang untuk memerhati proses di Kedutaan/Pejabat Diplomatik.

Pengelasan Pengundi pengundi lain sebagai Pengundi Pos

Selain daripada Pengundi Luar Negara, pihak kami mencadangkan beberapa kategori baru untuk pengundi pos Dalam Peraturan 3 (b) dan (c), kami bercadang bahawa calon-calon atau wakilnya, ejen-ejen yang bertugas*, atau sesiapa yang bertugas untuk sepenuh masa yang diiktiraf oleh SPR pengundian tersebut akan dilayak untuk undi pos pada hari undi atau hari undi awal.

Ini kerana kategori-kategori pengundi tersebut tidak mempunyai masa pada hari undi

untuk menggunakan hak mereka untuk mengundi. Ini adalah untuk memastikan keseluruhan rakyat mampu mengundi, terutamanya sesiapa yang bertugas pada pengundian tersebut.

Kami juga bercadang untuk pengundi yang bertugas penuh masa pada hari mengundi awal dan hari mengundi, calon pilihan raya, Ejen Pilihan Raya, Ejen Tempat Mengundi, Ejen Mengira Undi dan Wakil Parti Politik, ketua tempat mengundi (luar negara) dan ahli SPR untuk mengdakwat jarinya sebelum pukul 8 pagi pada hari undi (atau hari undi awal, jika pengundi tersebut bertugas pada masa itu).

Di samping itu, kami bercadang untuk sesiapa yang dirawat di hospital (awam atau swasta) atau seorang penghuni dalam rumah penjagaan yang didaftar termasuk dalam kategori-kategori di bawah Peraturan 3 untuk berlayak sebagai pengundi pos. Ini adalah tergantung jika doktor mengiktiraf perawat tersebut tidak sesuai untuk berkeluar hospital atau rumah penjagaan tersebut. Ini kerana, pesakit-pesakit atau penghuni tersebut tidak mampu keluar untuk mengundi. Sewaktu Pilihan Raya Negeri Johor (2022), pengundi telah dikenakan kompaun bernilai RM 1000 kerana dia melanggar perintah kuarantin (dia mempunyai penyakit COVID-19) dengan menghadir sebagai pengundi biasa. Untuk situasi pandemik, pilihan pengundian pos perlu dipertimbangkan.

Cadangan – cadangan boleh diserapkan melalui Pemberitahuan Warta Peraturan 3 untuk memperkembangkan kategori pengundi pos. Untuk jangka masa hadapan (contohnya proses mengdakwatkan pengundi), pemindahan undang-undang untuk mengesahkan kategori-kategori secara tetap.

Tindak Malaysia kini juga mencadangkan pindaan kepada kategori Pengundi Tidak Hadir dalam Peraturan-Peraturan Pilihan Raya (Pendaftaran Pengundi) 2002, untuk termasuk pengundi yang menetap di luar semp.

**Untuk ejen-ejen calon, mereka boleh diberikan pilihan untuk menjadi Pengundi Awal. Jika tidak, pihak kami mencadangkan ejen-ejen calon untuk mendaftarkan sebagai pengundi pos dalam jangka masa seminggu selepas tarikh akhir penamaan calon. Adalah tanggung jawab calon untuk menguruskan ejen-ejen dia untuk menjadi pengundi pos.*

Borang 2

Terdapat beberapa isu mengenai perkara Borang 2. Contohnya, alamat saksi dan keperluan saksi sebagai warganegara Malaysia. Kita mengakui SPR telah mengeluarkan video-video mengenai proses melengkapkan pengundian pos.

Cadangan 5 (Tanpa melibatkan pindaan undang-undang)

SPR perlu meneruskan kegiatan pendidikan secara talian seperti mana dilaksanakan sewaktu PRU15.

Cadangan 6 (Melibatkan pindaan undang undang)

Untuk keperluan saksi, pihak kami ingin cadangkan penambahan orang-orang layak untuk menjadi saksi. Ini disebabkan terdapat pengundi Malaysia di menetap di kawasan amat jauh daripada orang Malaysia yang terdekat. Kategori saksi tambahan ialah

- 1) Notari Awam (Bertauliah) luar negara
- 2) Pegawai Perdagangan yang bekerja untuk Kerajaan atau agensi Malaysia (contoh, MATRADE)
- 3) Pegawai atau orang yang disahkan oleh Kedutaan/ Pesuruhjaya Tinggi Malaysia (termasuk kakitangan Kedutaan Malaysia)

Perkara-Perkara Iain

Seksyen ini untuk perkara-perkara lain yang tidak dijelaskan dalam seksyen sebelum ini

Cadangan 7 (Tanpa melibatkan pindaan undang-undang)

Untuk mengelakkan kesilapan alamat atau ketinggalan maklumat pada sampul undi pos, pihak kami mencadangkan proses pencetakan maklumat untuk undi pos dibuat dengan teknologi automatik dan bekerjasama dengan syarikat seperti Datapos (M) Sdn Bhd (subsidiari Pos Malaysia) untuk perkhidmatan efisen untuk pem-prosesan sampul undi pos. Mengurangkan jarak antara Ejen Undi Pos (EUP) dan Pemerhati dengan Kerani Pengundian Pos. Ini untuk membenarkan EUP dan Pemerhati untuk memantau/memerhati proses pengeluaran dan pengiraan undi pos secara jelas.

Cadangan 8 (Melibatkan pindaan undang undang)

Pemerhati SPR menjadi kategori orang tetap yang dibenarkan untuk memerhati pengeluaran undi pos, pembukaan peti undi pos dan pengiraan undi pos. Buat sekarang, mengikut budi bicara SPR, Pemerhati telah dibenarkan untuk memerhati proses ini. Sampul yang diterima oleh Pegawai Pengurus selepas pukul 5 petang pada hari mengundi (biasa) harus ditanda sebagai “Ditolak”. Sampul tersebut mesti disimpan dalam kandung dikunci yang disedia khas untuk sampul iringan tersebut dengan kandungannya dikeluarkan. Kandungan tersebut perlu disimpan dalam peket yang dimeterai dan ditandatangani oleh pegawai pengurus dan calon atau ejen ejen yang hadir. Tandaan tersebut adalah untuk memastikan sampul yang diterima lewat tidak sah. Alasannya untuk pembezaan adalah untuk memastikan sampul iringan yang ditolak tidak dicampur dengan sampul yang diterima. Keselamatan tentang sampul sampul iringan tersebut mesti dijaga. **Pengundi domestik (iaitu pengundi biasa) yang menetap di negeri lain daripada negeri mengundi tidak akan dikategorikan sebagai pengundi pos. Pengundi domestik telah diberi peluang oleh SPR untuk mengemaskini maklumat pengundian setiap bulan. Jika SPR mahu membenarkan pengundi luar negeri (masih di Malaysia) untuk mengundi di negeri mereka menetap, SPR boleh mengkaji konsep undi awal.

Kesimpulan

Untuk memastikan pengundian dalam negara kita dilaksanakan dengan prinsip prinsip keadilan dan ketelusan, prosedur prosedur berkaitan dengan proses tersebut perlu dinyatakan dengan jelas. Kami berharap pindaan tersebut akan dilaksanakan dengan segera. Laporan ini telah disediakan oleh Liew Hong Wei (staf Tindak Malaysia) dan disunting oleh Danesh Prakash Chacko (Pengarah Tindak Malaysia). Laporan telah diperbaharui oleh Stephen Koh (Orang Sumber Pilihan Raya Tindak Malaysia) Tindak Malaysia, sebagai badan bukan kerajaan yang menumpukan terhadap proses pilihan raya,

ingin merakamkan ribuan terima kasih kepada penyumbang – penyumbang Projek Beres (sedekad lalu) dan sukarelawan - sukarelawan Tindak Malaysia yang menyumbang pendapat bernes pada tahun 2023. Walaupun segala penelitian telah diambil dalam penyediaan maklumat yang terkandung di dalam laporan ini, tiada waranti, secara nyata atau tersirat diberikan oleh TindakMalaysia Network Services PLT (Tindak Malaysia), mana-mana kakitangan atau sukarelawan Tindak Malaysia tidak bertanggungjawab atas apa-apa kesilapan atau ketinggalan yang mungkin berlaku. Tindak Malaysia dan mana-mana kakitangan atau sukarelawannya tidak dalam mana-mana keadaan akan bertanggungjawab bagi apa jenis ganti rugi, salah faham atau kerosakan.

Muka Surat seterus adalah statistik Undi Pos untuk PRU14 dan PRU15 (terdapat beberapa kerusi yang tidak mempunyai maklumat) dan Lampiran yang menunjukkan pindaan teliti.

PART I

PRELIMINARY

1. Citation, commencement and application

- (1) These regulations may be cited as the Elections (Postal Voting) Regulations 2003.
- (2) These Regulations come into operation on 16 June 2003.
- (3) These Regulations shall be read as one with the Elections (Conduct of Elections) Regulations 1981 [P.U. (A) 386/1981].

2. Interpretation

In these Regulations, unless the context otherwise requires--

"Form 2" means a declaration of the identity of a postal voter **and bearing the ballot paper number**;

"agent" means the election agent or any person appointed to attend in the election agent's place;

"assistant overseas agent" means an assistant overseas agent appointed under paragraph 8 A (3);

"ballot box" has the same meaning assigned to it by Regulation 2 of the Elections (Conduct of Elections) (Amendment) Regulations 2012 or may be a lockable sack used by the Election Commission to hold or to dispatch ballot papers;

"consular officer" means an officer in the Malaysian High Commission or Malaysian embassy who is appointed to be the "overseas presiding officer" by the Election Commission to conduct proceedings in respect of overseas postal votes under these Regulations;

"election observer" means a representative of a local or international organisation, who has been invited by the Election Commission to monitor the conduct of elections;

"issue" includes the original and any subsequent issue;

"overseas agent" means an overseas agent appointed under paragraph 8 A (3);

"overseas postal ballot paper" means any postal ballot paper issued to an overseas postal voter;

"overseas polling centre" means any Malaysian High Commission or embassy appointed by the Election Commission to receive overseas postal ballot papers;

"overseas polling day" means the last day for overseas voting that will be taken on a date or dates and time not more than two days earlier than a polling day;

"overseas postal voter" means any postal voter who is ordinarily resident in a place outside Malaysia;

"overseas presiding officer" means the consular officer designated under regulation 8 A or any other person appointed by the Election Commission to conduct proceedings in respect of overseas postal votes under these Regulations;

"political party's representative" means a person appointed by a candidate or election ~~representative agent~~ to act as an enforcement team member or advance polling agent or advance counting agent or advance booth observer;

"place outside Malaysia" includes any country or territory or division thereof outside Malaysia, and includes any combination of two or more countries or territories or divisions thereof outside Malaysia as may be specified in a notice published under paragraph 8 A (1);

"political party" means for the purposes of these Regulations, any society, registered under the Societies Act 1966 [Act 335] or registered by the Election Commission under Article 113A of the Federal Constitution;

"postal ballot paper" means a ballot paper issued to a postal voter;

"postal polling day" means the last day for postal polling that will be taken on a date or dates and time to be the same day as polling day;

"postal voter" means any person entitled to vote under regulations 3;

"absent voter" has the meaning assigned to it in the Elections (Registration of Electors) Regulations 2002 [P.U. (A) 293/2002];

"envelope A" means a covering envelope bearing the words "ballot paper envelope" ~~and "ballot paper number"~~;

"envelope B" means a covering envelope bearing the words "returning officer/consular officer" for the return of envelope A and Form 2.

PART II

POSTAL VOTERS

Regulation 3. Persons entitled to vote as postal voters.

(1) Any person who has registered as a Parliamentary or State elector under the Elections (Registration of Electors) Regulations 2002, and is--

(a) a person referred to in paragraphs (a), (b), (c), (d), (e), (f) and (g) in the definition of "absent voter" in regulation 2 of the Elections (Registration of Electors) 2002;

(b) a person referred to in paragraphs 27A(1)(a) and (c) of the Elections (Conduct of Elections) 1981 [P.U. (A) 386/1981] who is on full-time duty and unable to vote on both the advance polling day and polling day;

(c) a person certified by the Election Commission to be an election officer, candidate, election agent, counting agent, polling agent, political party's representative and liable for full-time duties on the both advance polling day or and polling day;

(cc) a person who is not an absent voter and certified by the Election Commission to be an overseas presiding officer;

(ccc) a person certified by the Election Commission to be an overseas agent or assistant overseas agent and not an absent voter residing overseas as prescribed in Regulation 2(g) (a), (b), (c), (d), (e), and (f) of the Elections (Registration of Electors) Regulations 2002 and is on duty at an overseas polling centre;

(d) a member of the Election Commission appointed under Article 114 of the Federal Constitution; or

(e) a member of any category of persons designated as postal voters by the Election Commission from time to time by notification in the Gazette;

(f) a person who is a long-term inmate in a registered nursing home or is hospitalized in a public or private hospital and certified by a doctor of the nursing home or hospital to be unfit to go out to vote on polling day.

shall, on receipt of a postal ballot paper, be entitled to vote as a postal voter at an election in accordance with these Regulations.

(2) A person referred to in—

(a) paragraph (1)(b) who is on full-time duty and unable to vote on the advance polling day and polling day and intends to vote by post; and

(b) paragraphs (1)(c), (cc), (ccc), (d), (e) and (f) who intends to vote by post; and

(c) paragraph (1)(g) in Regulation 2 of the Elections (Registration of Electors) 2002

shall apply to do so by using Form 1 in the Schedule not later than two days after nomination day. [(1) &(2) Subs. P.U.(A) 114/2012]

(3) The application shall be made direct to the returning officer of the constituency in which he is registered, or to the corresponding State Elections Officer, as soon as it is known that an election is contested in that constituency.

(4) If an application is approved, the returning officer or State Elections Officer shall issue a postal ballot paper to the applicant and if it is not approved, the returning officer shall so inform the applicant and shall state his grounds for not approving the application in the letter prescribed in Form 1.

(5) A person referred to in paragraphs 1(b), (c), (cc), (ccc), (d) and (e) shall if he is serving in an advance polling centre or polling centre arrange to mark his left forefinger with indelible ink in accordance with the procedures in Regulation 19 (8A) and (8B) of the Elections (Conduct of Elections) Regulations 1981 before 8 o'clock in the morning of advance polling day if he is on duty at the advance polling centre and in any case not later than 8 o'clock in the morning of polling day. Or at the office of the Returning Office not earlier than 3 days before polling day upon the presentation of the certification issued under Regulation 8(e).

3A. Persons entitled to vote as overseas postal voters

(1) Any person who has registered as an absent voter under Regulation 2 (a), (b), (c), (d), (e) and (f) of the Elections (Registration of Electors) Regulations 2002 and had prior to the dissolution of the Parliament or State Assemblies, submitted the prescribed Form to opt to receive the ballot paper via post shall, on receipt of an overseas postal ballot paper, be entitled to vote as an overseas postal voter at an election in accordance with these Regulations.

(2) A person referred to in paragraph (1) desiring to vote by post shall apply to do so by using Form 1 A in the Schedule.

(3) The application referred to in paragraph (2) shall be made at any time prior to the dissolution of the Parliament or State Assemblies, nomination day direct to a Malaysian consular officer in the place outside Malaysia in which the applicant resides or to any other consular officer who has been designated by the Election Commission for the purpose of receiving such applications from such place.

(4) If an application made under paragraph (2) is approved, the consular officer shall forward the Form 1 A to the Election Commission, and if it is not approved, the consular officer shall so inform the applicant and shall state his grounds for not approving the application in the letter prescribed in Form 1A .

(5) The Election Commission shall maintain a register of overseas postal voters, which shall be made available for public inspection online subject to the redaction of the overseas postal voters' postal addresses, and the returning officer shall issue an overseas postal ballot paper to each person who is listed in that register as being registered with respect to that constituency.

(6) A person who has been registered as an overseas postal voter pursuant to an application under paragraph (2) shall remain on the register of overseas postal voters until the conclusion of the first parliamentary general election after such application or apply to be removed from such register using Form 1 A, and may after such time apply to amend the postal address listed on the register.

4. Form of postal ballot papers

The ballot papers to be sent to postal voters shall be in the same form as, and indistinguishable from, the ballot papers delivered to other voters.

PART III

ISSUING OF BALLOT PAPERS

5. Persons entitled to be present at issue of postal ballot papers and opening of postal voters' ballot boxes

(1) No person other than--

- (a) the returning officer and his clerks;
- (b) the candidates;
- (c) an election agent or person appointed by a candidate or election agent to attend in the election agent's place; and,
- (d) members or officers of the Election Commission; and,
- (e) election observers,

may be present at the proceedings on the issue of postal ballot papers or the opening of postal voters' ballot boxes.

(2) If a candidate or election agent appoints a person under paragraph (1) (c), he shall give notice of the appointment to the returning officer, stating the name and address of the person so appointed at any time during the issue of the postal ballot papers or the opening of the postal voters' ballot boxes, as the case may be.

(3) If the person referred to in subregulation (2) dies or becomes incapable of acting, the candidate or election agent may appoint another person in his place and shall forthwith give to the returning officer notice in writing of the name and address of the person so appointed.

(4) A candidate may himself do any act or thing which any agent of his, if appointed, would have been authorized to do, or may assist his agent in doing any such act or thing.

(5) Where in these Regulations any act or thing is required or authorized to be done in the presence of the candidates or their agents, the non-attendance of any such person or persons at the time and place appointed for the purpose shall not, if the act or thing is otherwise duly done, invalidate the act or thing done.

6. Notice of issue of postal ballot papers

(1) The returning officer shall give each candidate or his election agent not less than twenty-four hours' notice in writing of the time and place at which he will issue postal ballot papers.

(2) Where any subsequent issue of postal ballot papers is to be made, the returning officer shall notify each candidate or his election agent as soon as practicable not less than twenty four hours beforehand of the time and place at which he will make such subsequent issue.

7. Marking of postal ballot papers

(1) Each postal ballot paper issued shall be perforated or stamped with the official mark or initialled by the returning officer and the name and number of the elector shall be called out.

(2) A list shall be made of the persons to whom postal ballot papers have been sent but without showing the serial number of the particular ballot paper issued.

(3) The number of postal ballot paper shall be marked in Form 2 and on the envelope A. A sample of the perforation pattern or the official mark of the returning officer or his initial shall be recorded on Form SPR 754A.

(4) Before the issue of postal ballot papers, the starting and ending serial number of the postal ballot papers shall be recorded on Form SPR 754A. This form shall be signed by the returning officer and any candidate, election agent or polling agent as attend and a copy extended to them.

7A. Marking of overseas postal ballot papers

(1) Each overseas postal ballot paper issued shall be perforated or stamped with the official mark or initialled by the returning officer and the name and number of the elector shall be called out.

(2) A list shall be made of the persons to whom overseas postal ballot papers have been sent but without showing the serial number of the particular ballot paper issued.

(3) A sample of the perforation pattern or the official mark of the returning officer or his initial shall be recorded on Form SPR 754A.

(4) Before the issue of overseas postal ballot papers, the starting and ending serial number of the overseas postal ballot papers shall be recorded on Form SPR 754A. This form shall be signed by the returning officer and any candidate, election agent or polling agent as attend and a copy extended to them.

8. Documents to be sent to postal voters

The returning officer shall send to every postal voter the following documents:

- (a) a ballot paper;
- (b) Form 2;
- (c) an envelope A; and
- (d) an envelope B; and
- (e) a certification that he is a postal voter.

8A . Overseas postal ballot papers

(1) The Election Commission may by notice published in the *Gazette* direct that all envelopes addressed to overseas postal voters in a place outside Malaysia shall be despatched and collected via a specified consular officer in or in the vicinity of such place and such notice shall specify the deadline for the receipt of overseas postal ballots by such consular officer, being not more than five o'clock in the afternoon of overseas polling day.

(2) All overseas postal ballot papers thus despatched shall only be eligible to be counted if returned to the overseas presiding officer stationed at the Malaysian High Commission or embassy appointed by the Election Commission before five o'clock in the afternoon of overseas postal polling day in accordance with these Regulations.

(3) Each political party and each candidate not belonging to a political party shall be entitled to nominate an overseas agent and assistant overseas agents in the location of such consular officer, and the names and contact details of such agents shall be notified to the Election Commission within five days of the publication of the notice under paragraph (1).

(4) Where the Election Commission has issued a notice under paragraph (1), regulations 9 A , 10 A , 13 A and 14 A shall apply in place of regulations 9, 10, 13 and 14 in respect of overseas postal ballot papers sent

to such place outside Malaysia, and regulations 15, 16, 17 and 18 shall apply with the substitution of “overseas presiding officer” for “returning officer”.

9. Despatch of postal ballot papers

All envelopes addressed to postal voters shall be counted and forthwith despatched according to the arrangements previously approved by the Election Commission.

9 A . Despatch of overseas postal ballot papers

(1) The returning officer shall, at the proceedings on the original issue of postal ballot papers, place all envelopes addressed to overseas postal voters which are to be sent via a specified consular officer in a packet sealed and affixed with security tape, signed by the returning officer and signed by each candidate or his election agent or polling agent as attend and who desires to sign the same, whereupon the packet shall be sent to that consular officer by the Election Commission through diplomatic courier.

(2) Upon receipt of the sealed packets from the Election Commission, the consular officer shall give the overseas agents and election observers in his location no less than 24 hours' notice of the time and place of the opening of the sealed packets.

(3) The consular officer shall, in the presence of the overseas agents and election observers, record the serial numbers of the security tape, open each sealed packet and note the number of envelopes addressed to overseas postal voters in respect of each constituency and despatch such envelopes to the overseas postal voters via the local postal system or any independent courier approved by the Election Commission for that purpose.

10. Provision of postal voters' ballot box

(1) The returning officer shall, at the proceedings on the original issue of postal ballot papers, provide a ballot box or ballot boxes for the receipt of envelope B when returned by the postal voters.

(2) Every such ballot box shall be shown open and empty to the agents and election observers present and shall then be locked by the returning officer and affixed with security tape and signed by the returning officer and the agents present who desire to sign on the security tape.

(3) Every such ballot box shall be numbered and marked "postal voters' ballot box" and with the name of the constituency for which the election is held.

(4) The returning officer shall make arrangements for the safe custody of every such ballot box and provide facilities, including cctv for the agents and election observers to assist in securing the ballot box.

10 A. Provision of overseas postal voters' ballot box or sack

All references to postal voters' ballot box can also be taken to mean a lockable sack used for the purpose of transporting or holding ballot papers securely.

(1) The consular officer shall, at the proceedings on the despatch of the envelopes addressed to overseas postal voters, provide a ballot box or ballot boxes for the receipt of envelope B when returned by the overseas postal voters.

(2) There shall be no fewer than one ballot box for each state for which overseas postal ballot papers for elections to the state Legislative Assembly are to be received, and no fewer than one ballot box for the Federal Territories and each state for which overseas postal ballot papers for elections to the House of Representatives are to be received.

(3) Every such ballot box shall be shown open and empty to the agents and election observers present and shall then be locked by the consular officer and affixed with security tape and signed by the consular officer and the agents present who desire to sign on the security tape.

(4) Every such ballot box shall be numbered and marked "overseas postal voters' ballot box" and with the name of the state or territories and the legislative body for which the election is held.

(5) The consular officer shall make arrangements for the safe custody of every such ballot box through the engagement of independent security agencies in a sealed room and provide facilities, including cctv for the agents and election observers to assist in securing the ballot box if they so desire.

11. Sealing up of lists of postal voters and counterfoils of ballot papers

(1) The returning officer shall, as soon as practicable after the completion of the issue of the postal ballot papers, and in the presence of the agents and election observers, make up into separate packets--

- (a) the list of postal voters; and
- (b) the counterfoils of those ballot papers which have been issued, and shall affix security tape on such packets.

(2) The packet which has been affixed with security tape containing the list of postal voters may be opened by the returning officer in the presence of the agents and election observers, for the purposes of a subsequent issue, and on completion of the subsequent issue, the list and the counterfoil of the ballot papers which have been issued shall be again made up into separate packets and affixed with security tape in accordance with subregulation (1).

12. Exercise of postal vote

A postal voter who wishes to exercise his postal vote shall exercise it by completing and despatching the ballot paper and Form 2 in accordance with the instructions laid down in such Form to the voter.

12A. Exercise of overseas postal vote

The Election Commission shall provide an adequate campaign period to ensure that all overseas postal voters are able to receive their ballots and to return it to the overseas presiding officer before five o'clock in the afternoon of overseas postal polling day.

13. Receipt of covering envelope

The returning officer shall, immediately on receipt of envelope B before five o'clock in the afternoon of polling day, place it unopened in a postal voters' ballot box which has been locked and affixed with security tape in accordance with regulation 10. Any envelope received by the returning officer after five o'clock in the afternoon of polling day shall be rejected and mark "Rejected" with the envelope unopened. This shall be kept in a locked sack specially provided for the purpose and the contents removed at the end of counting to be kept securely in a sealed packet that will be signed by the returning officer and the candidate, election agent, polling agent or counting agent present.

13A . Receipt of overseas covering envelopes

The consular officer shall, immediately on receipt of envelope B before five o'clock in the afternoon of overseas polling day, place it unopened in the appropriate overseas postal voters' box which has been locked and affixed with security tape in accordance with regulation 10A . Any envelope received by the overseas presiding officer after five o 'clock in the afternoon of overseas polling day shall be rejected and mark "Rejected" with the envelope unopened. This shall be kept in a locked sack specially provided for the purpose and the contents removed at the end of counting to be kept securely in a sealed packet that will signed by the consular officer and the candidate, election agent, overseas agent or assistant overseas agent present.

OPENING OF POSTAL VOTERS' BALLOT BOX

14. Opening of postal voters' ballot box

- (1) Each postal voters' ballot box shall be opened by the returning officer in the presence of the agents and election observers.
- (2) So long as the returning officer ensures that there is at least one postal voters' ballot box for the receipt of envelope B up to five o'clock in the afternoon of postal polling day, he may open the other postal voters' ballot boxes before then.
- (3) The returning officer shall give each candidate or his election agent at least twenty-four hours' notice in writing of the time and place of the opening of each postal voters' ballot box and the envelopes contained in the ballot box.

15. Opening of covering envelopes

- (1) When a postal voters' ballot box has been opened, the returning officer shall count and note the number of envelope B, record the number in Form SPR 754B and shall then open each envelope B separately.
- (2) An envelope B shall be marked "rejected"
 - (a) if it does not contain both Form 2 and an envelope A; or
 - (b) if it does not contain both Form 2 and a ballot paper.
- (3) If an envelope B contains only an envelope A, the returning officer shall open envelope A to ascertain that Form 2 is inside that envelope and if it is found not to contain Form 2, then the envelope B shall be marked "rejected".
- (4) An envelope B marked "rejected" together with its contents, if any, shall be placed in a separate receptacle.
- (5) On opening an envelope B, other than an envelope referred to in subregulation (3), the returning officer shall first satisfy himself that the Form 2 has been duly signed and authenticated and, if he is not so satisfied, he shall mark on the Form 2 "declaration rejected", attach to the Form 2 envelope A or, if there

| is no such envelope, the ballot paper shall be marked "rejected", and place it in the receptacle for votes rejected.

(6) Before placing the Form 2 in the receptacle for votes rejected, the returning officer shall show the Form 2 to the agents and, if any objection is made by any agent to his decision, he shall add the words "rejection objected to" on the Form 2.

(7) Where the number on the Form 2, has been duly signed and authenticated, agrees with the number on envelope A, the returning officer shall place the Form 2 in a separate receptacle and the envelope A in another receptacle.

(8) Where there is no envelope A or an envelope A has been opened under subregulation (3), the returning officer shall--

- (a)** where the number on the Form 2, has been duly signed and authenticated, agrees with the number on the ballot paper, place the declaration in the receptacle for declarations of identity and the ballot paper in a ballot box previously shown open and empty to the agents present and locked by the returning officer and affixed with security tape and signed by the returning officer and the agents desiring to sign on the security tape;
- (b)** where the number on the Form 2 has not been duly signed and authenticated, does not agree with the number on the ballot paper, mark on the Form 2 "vote rejected", attach to it the ballot paper which shall be marked "rejected" and place it in the receptacle for votes rejected.

(9) Where the number on the Form 2, duly signed and authenticated, does not agree with the number on an envelope or that envelope A has no number on it, the returning officer shall open the envelope and shall--

- (a)** where the number on the Form 2 agrees with the number on the ballot paper, place the Form 2 in the receptacle for Form 2 and the ballot paper in the ballot box referred to in paragraph (8)(a); and
- (b)** where the number on the Form 2 does not agree with the number on the ballot paper or there is no ballot paper, mark on the Form 2 "vote rejected", attach to it the ballot paper, if any, and place it in the receptacle for votes rejected.

(10) Except for the purposes of ascertaining under subregulation (3), whether an envelope A contains a Form 2, or under subregulation (9), whether the number on the Form 2 agrees with the number on the ballot paper, the returning officer shall not open envelope A before it is due to be opened under regulation 17.

16. Sealing up of rejected votes and Form 2

On the conclusion of the proceedings under regulation 15, the returning officer shall put the contents of the receptacle for votes rejected and the contents of the receptacle for Form 2 into two separate packets, and shall affix security tape on the packets and sign on it together with the agents.

17. Opening of envelope A

(1) After security tape has been affixed on the packets referred to in regulation 16, the returning officer shall open separately each envelope A placed in the receptacle for envelopes A.

(2) Where an envelope A does not contain a ballot paper, the returning officer shall mark on the envelope "empty".

(3) Where ~~the number on an a ballot paper is found in envelope A, agrees with the number on the ballot paper contained in the envelope;~~, the returning officer shall place the ballot paper in the ballot box referred to in paragraph 15 (8) (a) and shall put aside the envelope for immediate destruction.

(4) ~~Where the number on an envelope A does not agree with the number on the ballot paper contained in the envelope, the returning officer shall mark on the ballot paper "rejected" and attach the envelope A to it.~~

(5) The returning officer shall put into separate packets the envelopes marked "empty" and the ballot papers marked "rejected" and shall affix security tape on the packets, which shall be signed by him and the agents.

PART V

GENERAL

18. Procedure on the discovery of more than one ballot paper

At any stage when envelopes are opened in accordance with subregulation 15(1), (3) or (9) or subregulation 17(1), it is discovered that there is more than one ballot paper in an envelope, the returning officer shall mark the ballot papers "vote rejected" and place it in the receptacle for votes rejected, after checking the number on the ballot paper with the number on the Form 2 or an envelope A, as the case may be, place the correct ballot paper in the ballot box referred to in subregulation 15(8) and retain the other paper or together with all other documents and shall then make a statement of facts as discovered, witnessed by the candidates or agents present.

18A. Procedure to be followed in the securing of election documents

All election documents referred to in the preceding regulations shall be secured according to the tabulation shown in the Second Schedule and instructions therein.

19. Postal voter not to vote in person

A postal voter shall not be entitled to vote in person on polling day.

19A. Forms

(1) The Returning Officer shall make enough duplicates of all forms used in the whole process on postal voting and shall sign each and every form and be countersigned by each and every candidate or his election agent or postal agent present. A copy of each duly completed and signed form must be furnished to each and every candidate, his election agent, counting agent or agent.

(2) Failure of the Returning Officer to comply with subregulation 1 shall be deemed to be in breach of [section 4(g)] of the Election Offences Act 1954 and where there is any written complaint served on any returning officer and where the offence is established or proven, the appointment of the returning officer shall be terminated immediately by the Election Commission and a fine of RM5,000.00 shall be paid by the returning officer to the complainant.

20. Revocation

The Elections (Postal Voting) Regulations 1959 [L.N. 71 of 1959] and the Elections (Postal Voting) (Sarawak and Sabah) Regulations 1968 [L.N. (F) 184/68] are revoked

For postal voters within Malaysia, the ballot paper, in order to be counted, must be received by the returning officer not later than five o'clock in the afternoon of postal polling

day. If you are voting from overseas, the ballot paper, in order to be counted, must be received by the overseas presiding officer not later than five o'clock in the afternoon of overseas polling day.

6. If by mistake you receive more than one ballot paper, you are required to destroy the ballot paper whose number does not correspond with the number marked on the Form 2 image does not match the right part of the sample shown below with the names and party logos representing the candidates contesting in your constituency and if the images for more than one ballot paper matches the sample below, retain one valid paper and destroy the remainder. 
